This is regarding declaration of Results of the Examination for Direct Recruitment to the cadre of Postal Assistants in Postal Offices, Savings Bank Control Organization in Kerala Circle, Circle/Regional Offices, Returned Letter Office Trivandrum and Mail Moter services and Sorting Assistants in RMS Divisions from open Market conducted by CMC India Ltd. for the vacancies 2013 and 2014 held in Kerala Circle on 27/4/2014 and typing/computer test held from 12/7/2014 to 14/7/2014.

As per the Merit list given by the CMC India Ltd, received through Dte DO letter No. A-34013/05/2014-DE dated 26/9/2014 **list of selected candidates have been furnished division wise based on their merit –cum preference subject to availability of vacancies.** EX-serviceman and PH candidates have been allotted to the identified Divisions/units after horizontal adjustment of reservation/allotment of other Direct Recruitment qualified candidates under relevant category. The unfilled LGO vacancies for the year 2012 thrown open for Direct Recruitment from amongst GDS have been filled from amongst the GDS declared successful and the remaining unfilled vacancies have been added to DR quota under relevant category in the respective Postal/RMS divisions as per the enclosed Vacancy Summary as per the provisions contained in Recruitment Rules and as per the directions of the Directorate conveyed in letter No. A-34013/05/2014-DE dated 26/9/2014.


3. Dossiers of selected candidates are sent herewith to initiate further action. Divisional Heads are requested to take immediate action to complete the following pre-appointment formalities:

- i. List of selected candidates may be published in the Notice Board and selected candidates may be intimated by Reg/AD as per the address in the Dossiers today itself directing them to attend for Original Certificate verification within a week.
- ii. In case selected candidates fail to turn up for certificate verification, Notice (Regd/AD) may be given to the candidates concerned informing the proposed action to remove their name from the select list if they fail to respond with in ten days.

- iii. After the stipulated period proper Notice (Regd/AD) may be given to the candidates intimating the removal of their name from the select list.
- iv. Details of candidates removed from the select list and details of candidates refused to accept the offer of appointment may be intimated to this office so that candidates from the waiting list could be allotted for the drop outs according to the communal reservation.
- v. Selected candidates may be directed to report before DMO concerned for medical Examination.
- vi. Selected candidates may be informed of their provisional selection and subject to the verification of Documents like Educational qualification, caste, Age, Police verification and fulfillment of all terms and conditions.
- vii. Simultaneously necessary action may be taken to verify their Academic qualification through the concerned Board of Examination/University and character and antecedents through Police verification.
- viii. All the pre appointment formalities may be completed by 05 /11/2014 and compliance reported to this office.**

Postmaster General (Staff & Vig) Office of the Chief Postmaster General, Kerala Circle, Trivandrum-33 will take necessary above similar action in respect of candidates selected for the post of Postal Assistant in SBCO, Postal Assistant in Circle/Region Offices and Postal Assistant in Returned Letter Office. 
