Sub: - Direct Recruitment to the cadre of Postal Assistants / Sorting Assistants for the vacancies of 2017-18 on the basis of Combined Higher Secondary Level Examination-2017 conducted by SSC-reg.

Ref: - This office letter No. Rectt/4-3/2017-18(VP) dated 03.10.2017

Kindly refer to the above. This is regarding provisional selection of candidates under Direct Recruitment to the cadre of Postal Assistants in Post Offices, Sorting Assistant in RMS, Postal Assistants in Savings Bank Control Organization, Postal Assistants in Circle Office/Regional Offices and Postal Assisitant in RLO through Combined Higher Secondary Level Examination-2017 conducted by Staff Selection Commission for the vacancies of 2017-18.

2. Provisionally selected candidates have been allotted to Divisions/Units as per their merit and option exercised by them subject to availability of vacancies as detailed in Annexure-I. OBC, SC and ST candidates selected on their merit have been allotted to UR category.

3. APMG (Staff), Circle Office/ Divisional heads are requested to take immediate action to issue offer of appointment to the selected candidates **Provisionally** as per the instructions contained in the DoPT OMs/ Directorate instructions mentioned in this office letter no. Rectt/4-3/2015-16 dated 23.02.2018.

4. Appointing authority itself has to take necessary action for verification of the following certificates/ documents submitted by the candidates thoroughly from the issuing authority at the time of joining:

- i. Certificate regarding date of birth
- ii. Certificate relating to essential qualification as on date prescribed in the Notice of the exam.
- iii. SC/ ST/ OBC certificate, if any, issued by the competent Authority in the prescribed format approved by the Government of India. Certificates issued in any other format should not be considered.

- iv. In respect of OBC certificate, the guidelines regarding creamy layer status be strictly followed.
- v. Candidate's claim in respect of age relaxation, if any.
- vi. The offer of appointment should be sent to the provisionally selected candidate only by Registered post with AD to the address available in the Dossier sent along with this letter. If the letters are returned undelivered, the letter along with the envelopes containing remarks made by the postal authorities should be retained for record. In such cases, a copy of the offer of appointment should be sent to the permanent address and e-mail id of the candidates.

5. Appointment of selected candidates will be **PROVISIONAL** and subject to completion of formalities like verification of all records (Certificate of educational qualification, community etc), Medical Examination from Competent Medical Officer and other verification prescribed in the rules. However the appointment shall not be kept on hold on the ground that any such document appears to be suspicious. The provisional offer of appointment as well as the appointment order shall clearly specify if any information or document submitted by the candidate is found incorrect at later stage, which would have rendered him ineligible for appearing in the Combined Higher Secondary Level Examination, 2017 he/she shall be terminated from the service.


6. Your attention is also invited to Directorate letter No. 15-04/2015 SPB-I dated 30.11.2017 wherein approval of the competent authority was conveyed to discontinue the practice of execution of bonds under the provisions stipulated in Appendix 21 of Postal Manual Volume-IV by the direct recruit at the time of joining Department of Posts.

7. Appointment order issued to the provisionally selected candidates may also be endorsed to Recruitment Section, Circle Office. After completion of appointment process a consolidated report inter alia including name of candidates appointed, number of candidates refused to join and number of candidates who do not respond to offer of appointment may also be sent to Recruitment Section, Circle Office, along with the dossiers of the candidates who refused the job.

8. Offer of appointment may be issued to all the provisionally selected candidates by 24.07.2020 and all the pre appointment formalities may be completed as early as possible and compliance reported to this office.

9. The Dossiers in respect of candidates allotted to your Division/Unit are forwarded herewith. Kindly acknowledge the receipt of the same by next post.


