Sub: Declaration of results of Limited Departmental Competitive Examination limited to MTS officials and Competitive Examination limited to GDSs for recruitment to the post of Postman and Mail Guard for the vacancy year 2018 (01.04.2018 to 31.12.2018) to 2019 (01.01.2019 to 31.12.2019) held on 29.09.2019 - reg

In accordance with this office notification No Rectt/12-2/2019 dated 20.08.2019, the examination for recruitment to the cadre of Postman and Mail Guard from amongst MTS and Gramin Dak Sevaks (GDS) for the vacancy years 2018 and 2019 was held on 29.09.2019 (Sunday).

2. In accordance with the Directorate Instructions contained in letter No 17-08/2018-SPN-I dated 10.05.2019, as amended vide letters dated 10.06.2019, 20.06.2019, 28.06.2019, 11.07.2019, 23.07.2019 and 11.12.2019, the Data Entry Skill Test (DEST) for candidates qualified in Paper-I and Paper-II of the above exam held on 29.09.2019 was conducted on 08.03.2020.

3. In accordance with the Directorate instructions contained in letter No 17-08/2018-SPN-I dated 10.05.2019, the candidates who qualify in Paper-I, Paper-II and Paper-III separately shall be considered for final selection and their merit shall be drawn in order of marks secured in Paper-I since both Paper-II and Paper-III (DEST) are qualifying in nature.

4. The list of the selected candidates (arranged in the order of merit) of the Postal and RMS Divisions is shown in **Annexure – A**. In respect of candidates who scored equal marks in Paper-I, their inter-se seniority is fixed on the basis of length of MTS/GDS Service.

5. The result will also be available on the Circle website (www.keralapost.gov.in)

6. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of the information furnished by the Regions/Divisions and Units. In case there are any mistakes in the details of candidate(s), the same may be

intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidates was not eligible to take up the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list, as the case may be.

7. This result is further subject to outcome of Court /CAT cases, correction of clerical mistakes, if any. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Divisions are requested to verify the current status of the candidature of the selected candidates before appointing the candidate. The candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be appointed and such cases should be referred back to this office.

8. Since this is a Direct recruitment for GDS officials and GDS are outside the Civil services and for the first time they will be joining as Government employees as 'Postman/Mail Guard', the Divisional heads are requested to carry out all required pre-appointment formalities as provided in prevalent rules and instructions issued from time to time on the subject along with the verification of genuineness of Community certificate/PWD certificate against which category they are being selected. Before appointment, for both the MTS and GDS selected candidates, it should be ensured that no disciplinary case is pending/contemplated or no penalty is current against the surplus qualified candidates. The Divisional Heads are also advised to re-check the pre-requisite conditions prescribed for candidates with reference to Recruitment Rules and their recommendations made while forwarding the application forms.

9. Since the examination has been conducted using OMR sheets, the request for re-totaling/revaluation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act.

10. The candidates of reserved category i.e SC/ST/OBC/EWS/PWD who are shown as qualified on their own merit are selected against UR vacancies.

11. There are no eligible GDS candidates in RMS Divisions and the vacancies of Mail Guard – 25% from GDS through LDCE were unfilled.

12. In Part I of Annexure A, the results were declared based on the available qualified MTS officials in the parent Divisions. The remaining vacancies of Postman – 25% from MTS through LDCE were unfilled.



15. The Competent Authority has congratulated all the Selected Candidates.


