**ORDER**

**Memo No.ST/3-3/Dlg/2017 dated at Trivandrum-33 the 27-11-2020**

The Competent Authority has ordered promotion of the under mentioned HSG I General Line officials in Post Offices to the cadre of HSG I (Non Functional Grade) in the Pay Matrix Level-8 under Cadre Restructuring of Group 'C' employees in Post Offices and allotted/posted as noted against each.

2. If any vigilance/disciplinary case is pending against any of the above named officials, they should not be relieved for posting without obtaining specific orders from this office. If any punishment is current in respect of the above named officials, he/she should not be promoted before the expiry of the currency of punishment.

3. **Regional Heads will issue necessary posting orders in respect of the officials allotted to the respective Regions.**

4. Those who have already been placed in the pay matrix level 8 and got their pay fixed are not eligible for fixation of pay on this promotion. Others if any, will exercise their option under FR 22 (I)(a)(1) for fixation of pay within one month from the date of issue of posting orders.

5. Those who refuse HSGI (NFG) promotion offered above, will not be eligible for regular/officiating promotions to HSG I(NFG) for one year from the date of refusal. Such officials are also not eligible for placement in MACP till they accept regular promotion.

6. Wherever movement of officials is contemplated as per this order, they should be relieved within thirty days from the date of issue of posting order.




7. In case, if the officials fail to assume charge in the promoted post, within a period of 30 days from the date of issue of posting order, it will be presumed that he/she has declined the promotion offered.

8. In case the officials are not willing to accept promotion, the representation declining the promotion offered should be received in this office within 30 days from the date of issue of posting order.

9. As per Directorate letter No: 25-04/2012-P.E.-I(Vol-III) dated 05-12-2018, LSG, HSG-II, HSG-I and HSG-I(NFG) Posts will be deemed to have been upgraded to these grades only w.e.f the dates they are filled up, i.e, from the date the promoted official assumes the charge. Otherwise, the post will remain in the lower grade. Also, as per Directorate letter No: X-20-24/2019-SPN-II dated 27-05-19, the effective date of promotion in all cases shall be from the date of actual promotion and seniority of an official shall be counted from the date of actual promotion on regular basis subject to stipulation of inter se seniority as per the mode of recruitment.


