
In partial modification to this office memo No. ST/18/30/ACs/2015 dated 3-2-2020, the Competent Authority has ordered the promotion of the under mentioned Sorting Assistant to the cadre of Lower Selection Grade (Accounts line) in the Pay Matrix level - 5. On promotion she is allotted to the Region as shown against her.

- The Promotion ordered to Smt. Spain Rose. M, RMS TV division vide the above memo is hereby treated as cancelled as per the option made by the official dated 21-10-2020 and as per the Directorate letter No. 06-12/2010-SPB-II dated 30-11-2011.
- The Regional Office concerned will issue the posting order in respect of the promoted official posting her against the norm based regular LSG (Accounts line) vacancies.
- If any vigilance/disciplinary case is pending against the promoted official, she should not be relieved for posting without obtaining specific orders from this office. If any punishment is current, in respect of the promoted official she should not be promoted before the expiry of the currency of punishment.
- In case the promoted official is already placed in the Pay Matrix level - 5 under the TBOP scheme or have been granted the first financial upgradation under the MACP scheme and got their pay fixed, she is not eligible for fixation of pay on this promotion. Otherwise, will exercise her option under FR 22 (I) (a) (1) for fixation of pay within one month from the date of issue of posting orders.
- Promotion will take effect from the date of assumption of charge in the norm based LSG(Accounts line) posts pursuant to this order and necessary charge report may please be forwarded to this office.
- In case the official refuse the LSG(Accounts line) promotion now offered, she will not be eligible for regular promotion to LSG(accounts line) cadre for a period of one year from the date of such refusal and will not be considered for officiating promotion in the LSG posts. The official, if officiating in LSG, HSG II or HSG I posts, on adhoc basis, will be reverted immediately. Also the official will not be eligible for MACP placement in accordance with the provisions contained in Para 25 of Annexure I to Directorate Letter No. 4-7/ (MACPS)/2009-PCC dated 18.9.2009.
- Wherever movement of official is contemplated as per this order, she should be relieved within thirty days from the date of issue of posting order.


9. In case, if the official fails to assume charge in the promoted post, within a period of 30 days from the date of issue of posting orders, it will be presumed that she has declined the promotion offered.

10. In case the official is not willing to accept promotion, his/her representation declining the promotion offered should reach this office within 30 days from the date of issue of posting orders.
