


MINUTES OF THE COMMITTEE FOR COMPASSIONATE ENGAGEMENT(CCE)

The last meeting of the CCE was held at the office of the Chief PMG, Thiruvananthapuram on 04-8-2020 and 23-10-2020. 30 proposals were placed before the committee. The committee examined each case in detail based on the guidelines contained in Letter No 17-1/2017-GDS dated 30.05.2017, GDS (Conduct and Engagement) Rules 2021 amended from time to time and the instructions contained in the CO letter No. Rectt/7-2/RLGŠ/GDS dated 01-06-2021.

Engagement of approved cases is subject to the fulfillment of all eligibility conditions. The approved candidates should be engaged only after obtaining the required certificates duly verified, as per Directorate letter no.17-39/2012-GDS dated 20.05.2016. Before issuing engagement order, the Divisional Head should ensure that the approved candidates fulfill the condition of basic computer training, which is a mandatory requirement for engagement to GDS posts as per GDS(Conduct and Engagement) Rules, 2020.






