Sub: Declaration of results of Competitive Examination for recruitment to the cadre of MTS from eligible GDSs for the vacancy years 2018 (01.04.2018 to 31.12.2018), 2019 (01.01.2019 to 31.12.2019) and 2020 (01.01.2020 to 31.12.2020) held on 11.10.2020 - reg

In accordance with this office notification No Rectt/13-2/2020 dated 26.06.2020 and this office letter number Rectt/13-2/2020 dated 08.09.2020, 15.09.2020 & 09.10.2020, the Competitive Examination for recruitment to the cadre of MTS from eligible GDSs for the vacancy years 2018 (01.04.2018 to 31.12.2018), 2019 (01.01.2019 to 31.12.2019) and 2020 (01.01.2020 to 31.12.2020) was held on 11.10.2020.

2. The examination was conducted in accordance with the Directorate Instructions contained in letter No 17-08/2018-SPN-I dated 10.05.2019, as amended vide letters dated 10.06.2019, 20.06.2019, 28.06.2019, 11.07.2019, 23.07.2019 and 11.12.2019.
3. The list of the selected candidates for each vacancy year of 2018, 2019 and 2020 (arranged in the order of merit) of the Postal Divisions is shown in **Annexure - A, Annexure - B and Annexure - C** respectively. In respect of candidates who scored equal marks in Paper-I, their inter-se seniority is fixed on the basis of instructions contained in Directorate Letter No 04-08/2019-SPN-I dated 11.12.2020, communicated vide this office letter No Rectt/10-1/Rlgs/95 dated 08.01.2021.
4. The result will also be available on the Circle website (www.keralapost.gov.in)
5. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of the information furnished by the Regions/Divisions and Units. In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidates was not eligible to take up the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with

regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list, as the case may be.

6. This result is further subject to outcome of Court /CAT cases, correction of clerical mistakes, if any. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Divisions are requested to verify the current status of the candidature of the selected candidates before appointing the candidate. The candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be appointed and such cases should be referred back to this office.

7. Since this is a Direct recruitment for GDS officials and GDS are outside the Civil services and for the first time they will be joining as Government employees as 'MTS', the Divisional heads are requested to carry out all required pre-appointment formalities as provided in prevalent rules, collect valid Community certificate and follow the instructions issued from time to time on the subject along with the verification of genuineness of valid Community certificate against which category they are being selected. Before appointment, it should be ensured that no disciplinary case is pending/contemplated or no penalty is current against the GDS candidates and the Divisional Heads are also advised to re-check the pre-requisite conditions prescribed for candidates with reference to Recruitment Rules.

8. Since the examination has been conducted using OMR sheets, the request for re-totaling/revaluation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act.

9. The candidates of reserved category i.e SC/ST/OBC/EWS/PWD who are shown as qualified on their own merit are selected against UR vacancies.

10. There are no eligible GDS candidates in RMS Divisions, Circle Office Unit and MMS, Ernakulam Unit and the vacancies were unfilled.

11. The Divisional Heads are requested to collect the declaration of those candidates who are declining the selection as MTS, if any, within 21.01.2021 and intimate the details of such candidates to this office before 23.01.2021, for further processing of results for the left out vacancies immediately.

12. The list of Selected Candidates would be recast across the categories and year of vacancy, depending upon the acceptance or declining of selection by the Candidates.
