The competent authority has ordered the promotion of the under mentioned HSG - I General Line official in POs to the cadre of HSG - I (NFG) in POs in the pay matrix level - 8 and allotted/posted them as noted against their name.

2. If any vigilance/disciplinary case are pending against the above official, the official should not be relieved for posting without obtaining specific orders from this office. If any punishment is current in respect of the above official, the official should not be promoted before the expiry of the currency of punishment.

3. If the official has already been placed in the pay matrix level 8 and got their pay fixed then he/she is not eligible for fixation of pay on this promotion. Otherwise, the official may exercise their option under FR 22(D)(a)(1) for fixation of pay within one month from the date of issue of posting orders.


4. If the official refuses HSG - I (NFG) promotion offered above, he/she will not be eligible for regular/officiating promotion to HSG - I (NFG) for one year from the date of refusal. Such officials are also not eligible for placement in MACP till they accept regular promotion.

5. The official should be relieved within thirty days from the date of issue of posting order.

6. In case, if the official fails to assume charge in the promoted post within a period of 30 days from the date of issue of posting order, it will be presumed that he/she has declined the promotion offered.


7. In case the official is not willing to accept promotion, the representation declining the promotion offered should be received in this office within 30 days from the date of issue of posting orders.

8. As per Directorate letter no X-20-21/2019-SPN-II dated 27-05-2019, the effective date of promotion in all cases shall be from the date of actual promotion and seniority of the official shall be counted from the date of actual promotion on regular basis subject to stipulation of inter se seniority as per the mode of recruitment.
